## ICS responds to record number of calls

The volunteers and staff working on Monday, August 2, experienced a record number of client calls and visits.

More than 400 calls for

financial assistance were received. The Food Bank served nearly 90 families. More than ever before, we felt the frustration and fear of people facing homelessness and hunger, and our resources were stretched further than ever before.

Terri Patt-Smith, ICS Associate Director, has served as the senior case manager for 17 years. We asked her to share her thoughts on the increased needs in our community.

“During the past two years of economic downturn, many of the families we see have been ‘just hanging on,’” Terri said. “Statistics indicate that the average American family’s savings would last less than a month. For some, federal extensions of unemployment made it possible to survive, but the delay in the most recent extension

was enough to put people over the edge. I’ve talked to several families who were losing their cars due to falling behind on payments.

“We are seeing many

newly unemployed families. Some have jobs, but reduced hours or unpaid furloughs bring the income near or under the poverty level. More families are losing their medical benefits.

“Department of Economic Security benefits have been cut back for child care. This particularly hurts single moms who must spend more out-of-pocket in order to have their children in care so that they can work!”

So we at ICS are seeing these great needs now. We obviously cannot help all those in need, but we answer every phone call with a warm voice.

## ICS readying tools to help find jobs, manage money

ICS is poised to open a **Resource Center** at its Ina Road office to provide job-seeking assistance, computer classes on how to save and manage money, and help with signing up for the federal **Supplemental Nutrition Assistance Program (SNAP)**.

To assist the many unemployed and underemployed individuals in our community, ICS is working with **Pima County** to provide – on ICS computers and in print materials – the job-seeking information the county provides at its **ONESTOP** centers.

Users will be able to:

- Register for unemployment benefits.
- Look for jobs, job fairs and training opportunities.
- Work on and send out resumes and cover letters.

ICS will also be offering "financial literacy" classes – how to budget, build credit, buy a home, etc. – on CDs or on Resource Center computers.

The hours of the center have yet to be determined, and ICS is looking for volunteers who are interested in assisting with these kinds of services.

We are surveying ICS volunteers and recipients to better gauge the needs and desires for learning opportunities, job research skills and social services support. If you'd like to participate in the survey, contact Renee Sebag at 297-2738 x233 or Sandi Brickley at x217.

# "We Care" Golf Classic

## Health advocacy

ICS's Health Advocacy Outreach program continues to make inroads in assisting congregations develop their own health programs, bringing faith and health together. In addition to consulting with individual congregations, we present workshops for education and training.

• ICS is working with Carondelet Health Network and Duet: Partners in Health and Aging (Phoenix) to present a **training for people in congregations who are involved in health ministry/programs or who are interested in starting a health ministry/program** in their congregation. This two-day training will be geared to those who are not nurses. The course will cover such topics as "Religious, Cultural, and Historical Foundations of Health Ministry," "Building Blocks for a Health Ministry" and "Ethics and Accountability." Our food bank is available to everyone six days a week. When we can, we help people with rent, utilities, medication costs, work-related expenses. In addition to financial help, our case managers help clients set goals and action plans to reach sustainability. When funds and appointments run out, we help people find other options.

### ICS Gifts of Love help students

Thanks to your generous gifts, **331 young people** from low-income families were able to start school with **new school supplies** last month. That's an increase of 120 children, or 57 percent, over last year's total of 211. Donors valued their contributions at \$2,593 this year, up 75 percent from the \$1,477 in school supplies donated last year.

## ICS donors can claim state tax credit

As an Arizona taxpayer, your donations to ICS in 2010 may entitle you to a state tax credit when you file your state income tax return.

If you donate to ICS by December 31, you can claim a tax credit for 2010 that reduces dollar for dollar what you pay in state income tax.

Couples who file jointly can reduce their state taxes by up to \$400; individuals or head of household filers can claim a tax credit of up to \$200.

You can get this tax credit in addition to credits for public and private school donations. You can also claim your donation as a charitable deduction on your federal income tax return.

Here's what you need to do:

1) When you prepare your state tax return, itemize your deductions.

2) Complete Arizona Tax Form 321 and include it with your return.

ICS has been working with a group of 11 other Southern Arizona nonprofit organizations that serve the working poor to raise awareness about the tax credit.

## As an ICS donor, you have rights

To ensure that donors and prospective donors can have full confidence in ICS, the ICS Board of Directors endorsed “A Donor Bill of Rights” at its July 20th meeting. The Bill of Rights was developed by the Association of Fundraising Professionals and other philanthropy associations, and endorsed by United Way of America and other fundraising organizations.

According to the Donor Bill of Rights, all donors have these rights:

**I.** To be informed of the organization's mission, of the way the organization intends to use donated resources, and of its capacity to use donations effectively for their intended purposes.

**II.** To be informed of the identity of those serving on the organization's governing board, and to expect the board to exercise prudent judgment in its stewardship responsibilities.

**III.** To have access to the organization's most recent financial statements.

**IV.** To be assured their gifts will be used for the purposes for which they were given.

**V.** To receive appropriate acknowledgement and recognition.

**VI.** To be assured that information about their donation is handled with respect and with confidentiality to the extent provided by law.

**VII.** To expect that all relationships with individuals representing organizations of interest to the donor will be professional in nature.

**VIII.** To be informed whether those seeking donations are volunteers, employees of the organization or hired solicitors.

**IX.** To have the opportunity for their names to be deleted from mailing lists that an organization may intend to share.

**X.** To feel free to ask questions when making a donation and to receive prompt, truthful and forthright answers.

## 250 for \$250 Campaign

ICS is 60% of the way to the \$62,500 goal of our 250 for \$250 campaign. We began the campaign in the spring – as part of our 25th anniversary – to raise \$250 from 250 individuals or groups to provide much-needed services now. We will end this campaign on September 17.

Each \$250 donation received by September 17 will get two “special friend” tickets to ICS's 25th Anniversary Concert with R. Carlos Nakai and Gabriel Ayala on October 10 and will be listed in the program.
